Motions Made and Outcomes (include exact wording):

- 1. AOAO Foundation: Gary Ulrich, DO presented an update regarding the development of the virtual library. They are currently working on journal access. Any changes also affected other society meetings, making such adjustments for any group very difficult.
- 4. As there are difficulties with the Listserv, many members have been using GroupMe instead. It was agreed to make the rest of the members aware of this. To join, they will need to download the app, and provide the section with their email address or phone number to be added. Consideration to open this to non-section members.
- 5. Meeting moderators: Dr. Infante is moderating the Fall 2018 meeting in Atlanta.

Dr. Principe volunteered for the Spring 2019 meeting in Disney. Update since the meeting: Dr. Maxson volunteered for the Spring 2020 meeting in Las Vegas.
